

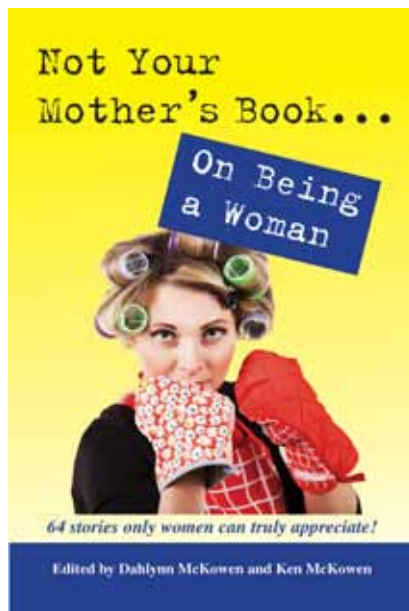

Why? Sales, plain and simple. In the publishing industry, book buyers rule the kingdom. They can either make you or break you. And they didn't care for the black covers because black has a tendency to show smudges. They weren't going to order.

We are so fortunate to now have Small Press United as our sales force. They

are very wise people. On the evening of Thursday, June 13th, we heard from our contact at SPU and he broke the news. They needed all new covers immediately. Throwing caution to the wind, we quickly came up with a new NYMB Woman cover and sent it to SPU. THEY LOVED IT! And they wanted all the book covers to be the same, to establish a look and a feel.



This is the cover sent to SPU. And it's now the official cover of our first NYMB book.

Our fate was sealed. And the reason I say that is because we had several books at the printer, actually on the press. We double-timed our graphic design efforts for a complete cover overhaul to get the new covers to the printer. If not, the new books—with the old covers—would be worthless and we would be out tens of thousands of dollars. So we redid the covers in 24 hours.

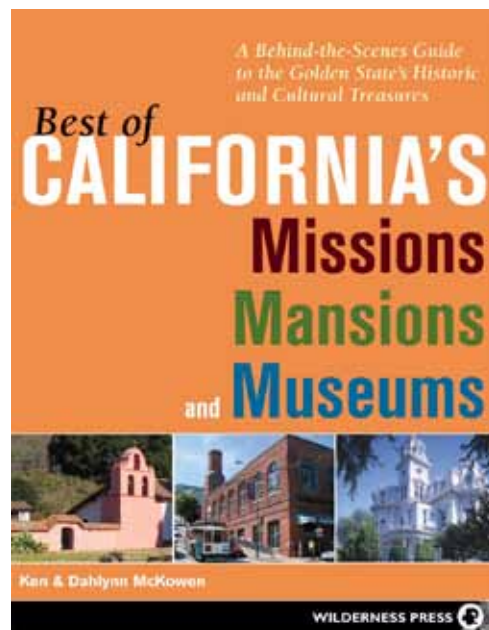
No, we're not complaining, but using this episode hopefully as a teaching moment. The publishing industry really doesn't know what it wants or what it likes. It's fickle. And it's cut-throat. What industry allows a customer (aka, bookstore) to return product up to two years later and get a complete refund, even if the product is damaged? The publishing industry. Hence, the trickle-down theory is put into motion:

1. The bookstore returns the product to the distributor (sales force)
2. The distributor refunds the bookstore the amount owing for the returned product
3. The distributor returns the product to the publisher, along with an invoice
4. The publisher pays the distributor the amount owed
5. The publisher takes the percentage of the return and debits it against the author's royalty statement, many times leaving the author with a negative royalty amount
6. The author will not receive a royalty until any new books sold bring the royalty statement out of the red

[Note: In most book contracts, publishers will hold back 25 percent of a royalty payment and put it into a holding fund to counteract returns. After a year, whatever is left in the fund is then paid to the author.]

Sometimes it's a wonder that authors make any money at all. Seriously. Once, when we were under contract with a publishing house, a big-box chain ordered 3,000 copies of our national award-winning travel guide on California. Woo hoo! Selling 3,000 books was great, and our royalty check was quite nice. Then the chain returned 2,700 books eight months later. It took us 16 months—and two royalty cycles with no checks issued, even though the books were still experiencing sales—to dig our way out of the red.

Where does it end? Back at Square One: as writers and authors and even publishers, we need book buyers to peddle our words. They have the power. Granted, one can self-publish and do well, but I'm not talking about that. I'm talking about running with the big dogs or playing with the big boys. It's time for Publishing Syndicate to put on our big-girl pants and step up. And we got it covered, literally.

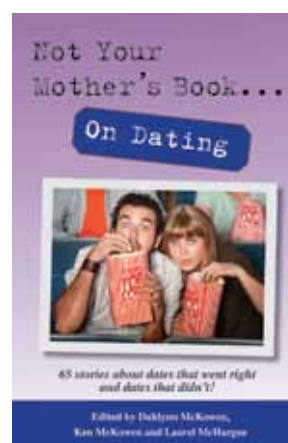
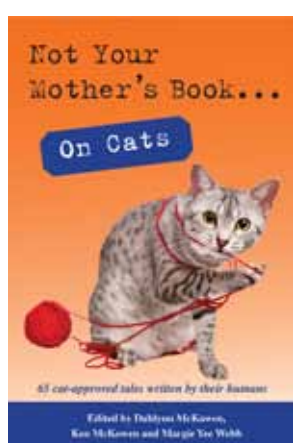
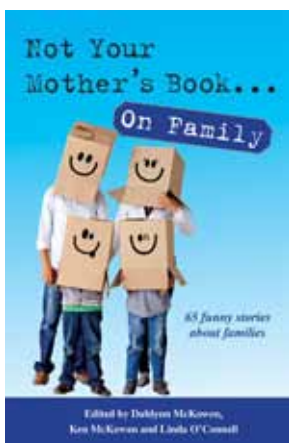
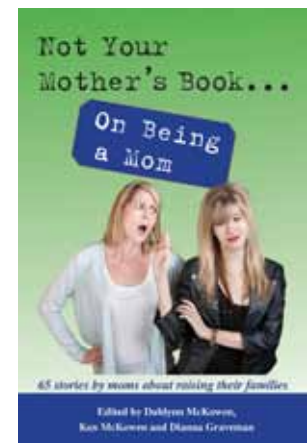
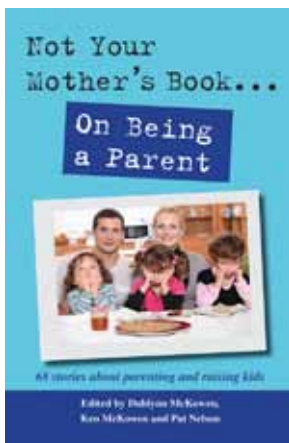
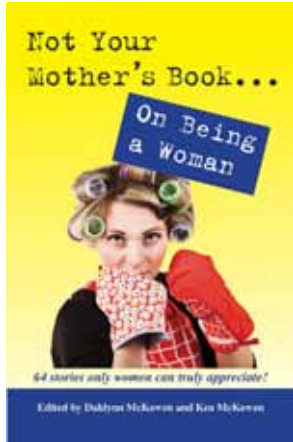

Results of Special DIY Call-Out

On June 7th, Publishing Syndicate issued a special story call-out for *Not Your Mother's Book... On Do-It-Yourselfers*, renamed *Not Your Mother's Book... On Home Improvement*.

This last-minute blast, which was sent to all subscribers on this newsletter's database, was to fill some holes in the manuscript. We needed just a few stories to round out some chapters.

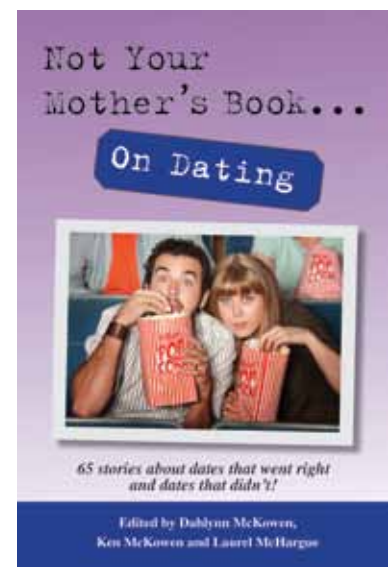
The response was overwhelming. There were nearly 650 opens of that call-out (yes, we can see who is opening our mailings!) and more than 60 stories submitted. In the end, only six stories were picked up for publication, with four of those six authors being first-time contributors to the NYMB series.

Having created anthologies since the late 1990s, we were surprised by the response—we had never seen anything like it. And all of us here at Publishing Syndicate had the same question: Why weren't these great stories submitted before the book's established deadline? Of the 60, at least 25 were good enough to be picked up for consideration during our normal first-round selection process.

Here are a few tips when submitting to our anthology:

1. Don't wait until the deadline to submit your stories. Typically, by the time the deadline rolls around, the co-creator is nearly done making his/her first-round story selections. Do you think we actually wait until the deadline to start a book? No! The book is in production at least three months before an established deadline.
2. Read this newsletter every month for announcements and updates
3. "Like" Publishing Syndicate on Facebook to be one of the first to get up-to-the-minute announcements and "scoops" as to last-minute story needs (plus, you'll have a blast—we have the best Facebook fans, and they're all writers like you!)
4. Check the Publishing Syndicate website often for new titles,

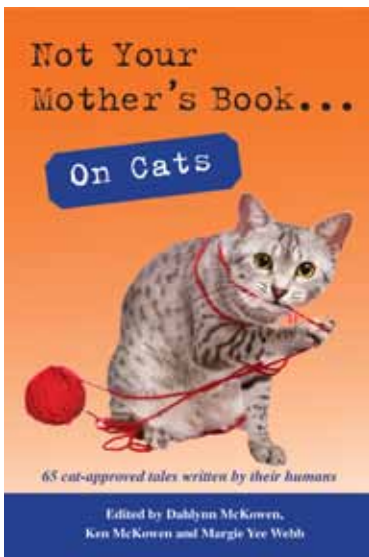

The story submission deadline has passed for this title. The book's co-creator—Margie Yee Webb—is now making the first-round selection of stories and will start the overall manuscript.

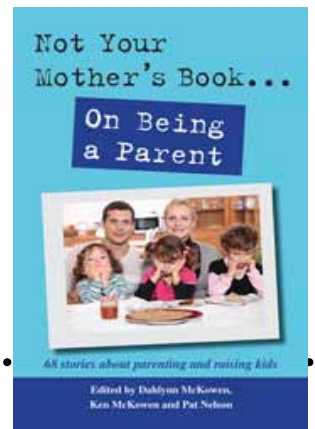

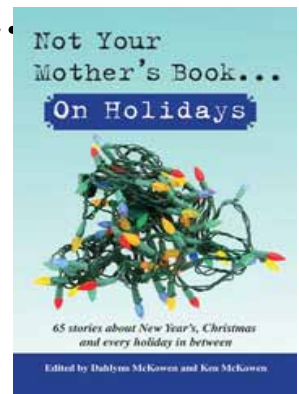


Not Your Mother's Book...On Home Improvement

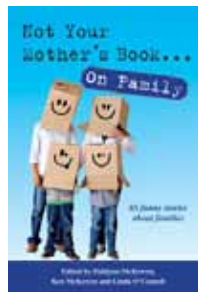

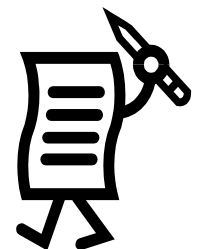
